

## **OPTIONAL SURCHARGE**

IF YOU HAVE SELECTED THE ENHANCED PLAN AND THE SURCHARGE HAS BEEN PAID, THE FOLLOWING COMPONENTS ARE COVERED:

#### **COOLING SYSTEM:**

Water pump, thermostat, mixture control valve, overflow reservoir, radiator cap.

## **FUEL SYSTEM:**

Fuel pump, pressure regulator, fuel injector, fuel cap.

## 1-TON: PAYLOAD CAPACITY:

Classification coverage for pickup trucks and sport utility vehicles. Manufacturer payload capacity covers vehicles less than or equal to the maximum allowed 1–Ton.

## **TURBO/SUPERCHARGER:**

If your vehicle is equipped with a Turbo Charger/Supercharger, all internally lubricated parts due to a Breakdown.

## **4WD/AWD: DRIVETRAIN TYPE:**

Coverage for vehicles with a drivetrain that allows all four wheels to receive torque from the engine. This drivetrain type may be a part-time or full-time system which uses multiple-differential housings. Refer to II. Coverage, COVERED COMPONENTS AND BENEFITS INCLUDED, E. Differential for more details regarding the specific differential assembly components.



If you have followed the manufacturer's recommended maintenance intervals for replacement.

#### **CV JOINTS:**

CV boots must not be torn at the time of Breakdown. Lubricated joint failure only. Universal Joint ( U Joint) is not included.

#### **STEERING:**

Internally lubricated parts contained within the steering box and pump housing, including rack and pinion, control valves, internal oil control seals, bearings, and shafts, steering box and pump housing if damaged by the failure of internally lubricated parts.

## **ELECTRICAL:**

Alternator, starter motor, front wiper motor, cooling fan motor, heater blower motor, electric horn, switches for the following: neutral safety, overdrive, reverse indicator, power windows, power door locks, power mirror.

## **AIR CONDITIONING:**

Compressor; however, if the damages or malfunctioning compressor causes damage to the expansion valve, and/or orifice tube, receiver dryer, the damaged component(s) will bee replaced. Coverage applies to factory installed, non-retrofitted units only.

LIMIT OF LIABILITY- ENHANCED PLAN: Our minimum liability under the Enhanced Plan: The total of all claims and benefits paid or payable while this Agreement is in force shall in no event exceed the lesser of the Actual Cash Value (ACV) of the Vehicle at the time of repair as determined by the NADA used car guide or five thousand dollars (\$5,000.00).

## **COVERAGE INCLUDES:**

**ENGINE:** cylinder block, cylinder heads, and all internally lubricated parts including: pistons, piston rings, connecting rods, connecting rod bearings, crankshaft and main bearings, camshaft and liters/followers (lifters or followers which have not failed, and only require cleaning are not covered), intake an exhaust valves, push rods, rocker arm shafts, rocker arms, timing drive components including timing chains/belts (timing chain or belt which is being changed as part of the manufacturer's preventive maintenance schedule, is not covered). Valve train covers, intake and exhaust manifolds, flywheel, oil pump, and oil pan. Internal engine sensors. The engine block, cylinder heads and turbocharger/supercharger housing are also covered if the above–listed parts caused a **Breakdown** of the engine block, cylinder heads or turbocharger/supercharger housing.

**AUTOMATIC TRANSMISSION:** Case and all internally lubricated parts including: planetary gear systems, clutch and steel packs, clutch drums, bands, internal seals, pump, valve body, internal sensors and internal solenoids, and overrunning or one way clutch assemblies. Torque converter and the torque converter housing.

**STANDARD TRANSMISSION:** Case and all internally lubricated parts, including: input shaft, output shaft, idler shafts, main shaft, all internal gears, shift forks, and synchronizer assemblies. **Standard transmission clutch assemblies, linkages, any hydraulic clutch units are not covered.** 

TRANSFER CASE: Transfer case on all internally lubricated parts.

**DIFFERENTIAL:** Front or rear differential housing and all internally lubricated parts (excluding wheel bearings). Driveshaft universal joints. (NOTE: Front or rear cv joins and front or rear wheel bearings are NOT covered).

**LABOR:** Labor charges to repair or replace a covered component are based on AllData or Mitchell flat rate time and the lesser of the **Repair Facility's** posted labor rate or up to one hundred (\$100.00) per hour.

**SEALS & GASKETS:** Provides replacement of seals and gaskets which are leaking fluids (lubricants or coolant). Slight seepage is not considered to be a covered repair (size of a quarter in 24 hours). (NOTE: Vacuum leaks are not covered).

LIMIT OF LIABILITY: Our maximum liability under the Power-Train coverage: Per Component – OUR LIABILITY FOR ANY ONE (1) COVERED COMPONENT SHALL IN NO EVENT EXCEED \$3,000.00 FOR ENGINE AND WATER PUMP, \$2,000.00 FOR TRANSMISSION/TRANSAXLE AND TRANSFER CASE CLAIMS \$1,000.00 AGGREGATE – THE TOTAL OF ALL CLAIMS AND BENEFITS PAID OR PAYABLE WHILE THIS AGREEMENT IS IN FORCE SHALL IN NO EVENT ESCEED T HE LESSER OF THE ACTUAL CASH VALUE (ACV) OF THE VEHICLE AT THE TIME OF REPAIR AS DETERMINED BY THE NADA USED CAR GUIDE OR [NINE THOUSAND DOLLARS (\$9,000.00)].

# ROADSIDE ASSISTANCE SERVICES & BENEFITS – No Deductible applies to the following benefits:

Emergency Roadside Assistance is available throughout the United States. Canada and Puerto Rico, twenty-four (24) hours a day, three hundred sixty-five (365) days a year. When arranging for 24-hour Roadside Assistance please call (844) 735-1784. You will be required to give the representative assisting You the following information: Producer Code — 159812, Agreement Number (located on the front right-hand corner of Your application page), and Your Produce Code which is "244 ESW". You will not be required to pay any additional fee or sum in addition to the contract fee when Your service is for a tow of up to twenty-five (25) miles or other covered service listed below. You are entitled to one (1) free service within a seventy-two (72) hour period. The number of covered Emergency Roadside Assistance Claims shall not exceed four (4) occurrences per Agreement Year. Important: Please be with Your Vehicle when the service provider arrives, as they cannot service an unattended vehicle. Service provided must be a covered benefit under the terms and conditions described. Please note: Coverage is extended to the registered vehicle only.

**TOWING:** Up to twenty–five (25) miles at no out of pocket expense to **You**. Additional mileage is available and will be negotiated prior to sending out a service vehicle. Additional mileage is to be paid by You directly to the service provider at the time of service.

**BATTERY SERVICE:** Jumpstart or boost a dead battery.

**DELIVERY SERVICE:** Including gasoline, water, oil, or any supplies necessary to send the Vehicle on its way. **You** are responsible for the actual cost of fluid and/or supplies delivered.

**TIRE SERVICE:** If **You** get a flat tire, **Your Vehicle's** spare tire will be installed, as long as it's inflated and serviceable.

**LOCKOUT SERVICES:** We will send a locksmith if **You** are accidentally locked out of the Vehicle. Access to passenger compartment only.

**RENTAL:** In the event of a **Breakdown** covered by this Contract, **We** will pay or reimburse **You** for receipted expenses to rent a replacement vehicle (from a licensed rental agency) while **Your Vehicle** is at a licensed **Repair Facility**. Coverage will be provided to You on the following basis, up to a maximum of fifty dollars (\$50.00) per day, for a maximum of five days, up to a maximum of two hundred and fifty dollars (\$250.00).

**TRIP INTERRUPTION:** In the event of a **Breakdown** of a covered component or part, **We** will reimburse **You** up to a maximum of two hundred dollars (\$200.00) per day for a maximum of five (5) days, not to exceed a total of one thousand dollars (\$1,000.00) for any expenses incurred by or for meals and/or lodging profiled. You cannot operate **Your Covered Vehicle** due to a **Breakdown** covered by this **Agreement** and are more than one hundred (100) miles away from home, and expenses are incurred between the time of **Breakdown** and the time repairs are completed. (The date of **Breakdown** shall be considered the first day).
